AN ORDER REORGANIZING THE BIDS AND AWARDS COMMITTEE (BAC) OF THE MUNICIPALITY OF PALANAN, ISABELA.

WHEREAS, pursuant to the provisions of Republic Act 9184 otherwise known as the "Government Procurement Reform Act" and its implementing Rules and Regulations, there shall be established a single Bids and Awards Committee to oversee and supervise the procurement process of agencies concerned;

WHEREAS, it is the declared policy of the state to promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and/or controlled corporations and local government units;

WHEREAS, the creation of the Bids and Awards Committee is necessary to establish a transparent, competitive, streamlined procurement process, accountability and public monitoring of all bidding of contracts and its implementation;

NOW THEREFORE, I, ELIZABETH B. OCHOA, Municipal Mayor of Palanan, Isabela, by virtue of power vested in me by law, do hereby order:

Section I. The Bids and Awards Committee (BAC) of the Municipality of Palanan, Isabela is hereby created.

Section II. The BAC shall be composed of the following:

Section III. The members of the BAC shall elect among themselves who shall act as the Chairman and Vice Chairman, provided that the Chairman shall be at least the third ranking official of this LGU.

Section IV. The members shall serve for a term of one (1) year effective upon approval of this order.

Section V. The **BAC Secretariat**. There shall be created a BAC Secretariat, which shall serve as the main support unit of the BAC. The BAC Secretariat shall be composed of the following:

Section VI. The Technical Working Group (TWG). There shall also be created a technical working group to provide technical assistance to the BAC, which shall be composed of the following:

Section VII. All orders, rules and regulations inconsistent with this order are hereby repealed.

Section VIII. This Order shall take effect immediately upon approval.
