AN ORDER CREATING THE BARANGAY DEVELOPMENT COUNCIL (BDC) MUNICIPAL ASSESSMENT TEAM (MAT) OF THE MUNICIPALITY OF PALANAN, ISABELA

WHEREAS, to harmonize the duties and functions of the BDC pursuant to existing laws, the Department of the Interior and Local Government issued Memorandum Circular (MC) No. 2019-69 dated May 15, 2019, amending the guidelines prescribed by DILG MC No. 2009-109;

WHEREAS, the new DILG issuance mandates all Local Government Units to create a Municipal Action Team (MAT) to evaluate the functionality of the Barangay Development Councils;

NOW THEREFORE, I, ELIZABETH B. OCHOA, Municipal Mayor of Palanan, Isabela, by virtue of the powers vested in me by law, do hereby order the creation of the MAT:

SECTION 1. COMPOSITION. The MAT shall be composed of

SECTION 2. FUNCTIONS OF THE MUNICIPAL ACTION TEAM. The MAT shall have the following functions:

- a. Assess the functionality of the BDC based on the submitted barangay self-assessment form;
- b. Review and evaluate the means of verification and relevant documents for the assessment of the BDC Functionality;
- c. Conduct validation activities whenever necessary; and
- d. Submit consolidated monitoring report and assessment results to the DILG Provincial Office;

SECTION 3. PERIOD COVERED AND FREQUENCY OF ASSESSMENT. The assessment of the functionality of the BDCs shall be conducted annually in accordance with the following schedule:

Year Under Review	Assessment Period	Submission of Regional Assessment Results
Previous Year	July to September of current year	On or before September 30 of every year

SECTION 4. EFFECTIVITY. This Order shall take effect immediately and copies hereof shall be furnished to all concerned for their information and reference.
