EXECUTIVE ORDER NO. 12
Series of 2019

AN ORDER ADOPTING SANGGUNIANG BAYAN RESOLUTION 2019-95, RESOLUTION RECONSTITUTING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF PALANAN, PROVINCE OF ISABELA.

WHEREAS, pursuant to Section 43 (d) (4), Republic Act No. 6975, otherwise known as the "Department of Interior and Local Government Act of 1990" governing investigation and disposition of administrative complaints filed against members of the Philippine National Police (PNP) before the People's Law Enforcement Board (PLEB);

WHEREAS, Section 43, subsection (b) paragraph (1) of RA 6975 as amended by RA 8551, otherwise known as the Philippine National Police Reform and Reorganization Act of 1998 prescribes the composition and term of office of the People's Law Enforcement Board;

WHEREAS, Section 4 of Rule 11 of NAPOLCOM Memorandum Circular 2016-002, entitled, "Revised Rules of Procedure before the administrative disciplinary authorities and the internal affairs service of the Philippine National Police", read as follows:

"Sec. 4. Resolution and Executive Order Constituting the PLEB. – The Sangguniang Panlungsod/ bayan shall pass a resolution formally organizing the members of the PLEB, a copy thereof shall immediately be submitted to the City/ Municipal Mayor who shall within five (5) days) from receipt of the same, issue the appropriate executive order adopting the resolution of the Sanggunian concerned. A copy of the said Executive Order shall be furnished the NAPOLCOM Regional Office within ten (10) days from issuance."

WHEREAS, on November 22, 2018, the Municipal Peace and Order Council during their 4th Regular Quarter Meeting, issued RESOLUTION NO. 2018 -04, entitled, "RESOLUTION ENDORSING THE THREE (3) RESPECTED MEMBERS OF THE COMMUNITY AS PLEB MEMBERS TO THE SANGGUNIANG BAYAN OF PALANAN, ISABELA";

WHEREAS, on July 5, 2019, the Sangguniang Bayan of Palanan, Isabela issued Resolution No. 2019-35, entitled, "RESOLUTION RECONSTITUTING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF PALANAN, PROVINCE OF ISABELA";

WHEREAS, on July 5, 2019, the Sangguniang Bayan of Palanan, Isabela issued Resolution No. 2019-34, entitled, "RESOLUTION DESIGNATING HON. ROBERT B. NERI AS MEMBER OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF PALANAN, PROVINCE OF ISABELA";

WHEREAS, the recent local elections necessitate the reconstitution of all Local Special Bodies to integrate the new set of elective officials as member of the different special bodies;

NOW THEREFORE, I, ELIZABETH B. OCHOA, Municipal Mayor, Palanan, Isabela, by virtue of the powers vested in me by law, do hereby order:

SECTION I. Sangguniang Bayan Resolution No. 2019 – 95, entitled, "Resolution Reconstituting the People's Law Enforcement Board (PLEB) of the Municipality of Palanan, Province of Isabela", is hereby formally adopted for the Term 2019-2020.

SECTION II. Pursuant to the aforesaid Resolution, the composition is hereby reconstituted and adopted as follows:

SECTION III. The duties, functions and responsibilities, term of office and other matter involving PLEB Palanan are those provided in RA 6975 (Department of the Interior and Local Government Act of 1990), as amended by RA 8551 (Philippine National Police Reform and Reorganization Act of 1998), NAPOLCOM Memorandum Circular 2016-002, entitled, "Revised Rules of Procedure before the administrative disciplinary authorities and the internal affairs service of the Philippine National Police", and other relevant laws and issuances.

SECTION IV. Copies of this Executive Order shall be furnished to NAPOLCOM Regional Office, PNP Palanan, DILG Palanan, DILG Isabela and other government agencies concerned, within ten (10) days from date of issuance hereof, for their information, guidance and appropriate action.

SECTION V. All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

SECTION VI. This Executive Order shall take effect immediately.
