EXECUTIVE ORDER NO. 13

AN ORDER CREATING THE CY 2020-2022 PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN TECHNICAL WORKING GROUP OF THE MUNICIPALITY OF PALANAN, PROVINCE OF ISABELA.

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and Executive Order No. 773, Series of 2009, call for the further reorganization and strengthening of the peace and order councils in every province, city and municipality;

WHEREAS, Memorandum Circular No. 2015-130 dated November 3, 2015 of the Department of the Interior and Local Government (DILG) provides guidelines on the function of the Peace and Order Council, Barangay Peace and Order Committees and the Peace and Order Council Secretaries;

WHEREAS, paragraph A (2) (k) of Memorandum Circular No. 2015-130 mandates the council to create a Technical Working Group (TWG) for the purpose of Peace and Order and Public Safety (POPS) planning;

WHEREAS, on May 17, 2019, the Municipal Peace and Order Council during their 2nd Regular Quarter 2019 Meeting, issued RESOLUTION NO. 2019 -03, entitled, "RESOLUTION ENDORSING TO THE LOCAL CHIEF EXECUTIVE THE CREATION OF TECHNICAL WORKING GROUP FOR THE PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLANNING AND FORMULATION";

WHEREAS, there is a need to reorganize the composition of the Peace and Order and Public Safety (POPS) Plan Technical Working Group in order to formulate the CY 2020-2022 Peace and Order and Public Safety (POPS) Plan;

NOW THEREFORE, I, ELIZABETH B. OCHOA, Municipal Mayor, Palanan, Isabela, by virtue of the powers vested in me by law, do hereby order:

SECTION I. COMPOSITION. Pursuant to the aforesaid MPOC Resolution, the composition of the Peace and Order and Public Safety (POPS) Plan Technical Working Group is hereby reconstituted and adopted as follows:

SECTION II. DUTIES AND RESPONSIBILITIES. The Technical Working Group (TWG) shall undertake the following duties and responsibilities:

- (1) Provide technical assistance in the formulation of a 3-year term-based Peace and Order and Public Safety Plan as prescribed under DILG MC No. 2015-128;
- (2) Present and submit the draft CY 2020 -2022 POPS Plan to the Peace and Order Council for review;
- (3) Ensure final approval of POPS Plan to the MPOC for submission and approval of the Sangguniang Bayan; and
- (4) Perform other tasks as may be directed by the Council;

SECTION III. EFFECTIVITY. This Executive Order shall take effect immediately.
