EXECUTIVE ORDER NO. 15 Series of 2019

AN ORDER ORGANIZING THE MUNICIPAL MONITORING AND REPORTING COMMITTEE FOR CIVIL SOCIETY ORGANIZATION (CSO) ACCREDITATION IN THE MUNICIPALITY OF PALANAN.

WHEREAS, Article 62, Rule XIII of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act No. 7160) mandates local government units to promote the establishment and operation of people's organizations, non-governmental organizations, and the private sector, to make them active partners in the pursuit of local autonomy;

WHEREAS, Article 64 of the same *Implementing Rules and Regulations* provides for the procedures and guidelines for the selection of representatives of CSOs in local special bodies and the criteria for accreditation that shall guide the concerned Sanggunian on the accreditation of CSOs for the purpose of representation to the local special bodies;

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular 2019-72 dated May 22, 2019 to provide guidelines on the process for accreditation and selection of CSOs and their representatives to the local special bodies;

WHEREAS, Section 10 of DILG MC 2019-72 mandates the organization of a Municipal Monitoring and Reporting Committee for Civil Society Organization (CSO) Accreditation to ensure that the pertinent provisions of RA 7160 and DILG MC 2019-72 are strictly and faithfully observed;

NOW THEREFORE, I, ELIZABETH B. OCHOA, Municipal Mayor, Palanan, Isabela, by virtue of the powers vested in me by law, do hereby organize the Municipal Monitoring and Reporting Committee for Civil Society Organization (CSO) Accreditation in the Municipality of Palanan, Isabela:

SECTION I. COMPOSITION. The Municipal Monitoring and Reporting Committee for Civil Society Organization (CSO) Accreditation shall be composed of the following:

SECTION II. DUTIES AND RESPONSIBILITIES. The Municipal Monitoring and Reporting Committee shall have the following duties and responsibilities:

- (1) Ensure that the intent of DILG MC 2019-72 is complied with by the Municipal Government of Palanan;
- (2) Generate reports and recommend measures to help strengthen the participation of CSOs in the workings of special bodies and in the local governance of the municipality;
- (3) Perform other related tasks as may be necessary in the effective implementation of this Order;

SECTION III. EFFECTIVITY. This Executive Order shall take effect immediately.
