EXECUTIVE ORDER NO. 19 Series of 2019

AN ORDER REORGANIZING THE COMPOSITE BUILDING INSPECTION TEAM AND THE CREATION OF THE INFRASTRUCTURE AUDIT COMMITTEE OF THE MUNICIPALITY OF PALANAN, ISABELA

WHEREAS, it is the policy of the State to safeguard the integrity of its territory and well-being of its citizenry and provide effective mechanisms or measures to ensure public safety, law and order;

WHEREAS, it is the policy of the State to build the capacities of local government units for disaster preparedness to reduce the socio-economic and environmental impacts of disaster;

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular 2011-47 dated March 31, 2011 for the Mandatory Inspection of Local Government Infrastructure Projects and Public Buildings;

WHEREAS, pursuant to Executive Order No. 28 dated October 24, 2016 issued by the Provincial Governor of Isabela, directing all Local Government Units to create their respective composite LGU building inspection team in-charge of ensuring the structural integrity and fire safety of buildings in the Province of Isabela;

WHEREAS, in accordance with policy, there is a need for local government units to enhance existing mechanisms for public safety and ensure that structures are used according to the purpose for which the structures were built, and that no fire and other LGU permits shall be issued unless and until the structures have been evaluated and inspected by the municipal inspection team, except for structures with issues which will be referred to by the inspection team;

WHEREAS, the creation of an infrastructure audit committee is likewise needed to ensure that the Infrastructure Audit is regularly conducted and the required Infrastructure Audit Report are submitted to concerned authorities;

NOW THEREFORE, I, ELIZABETH B. OCHOA, Municipal Mayor of Palanan, Isabela by virtue of powers vested in me by law, do hereby order the following:

SECTION I. COMPOSITION. The composition of the Composite Building Inspection team shall be reorganized as follows:

SECTION II. INFRASTRUCTURE AUDIT COMMITTEE. The Infrastructure Audit Committee is created to ensure that infrastructure audit is conducted and the reports required are submitted to concerned authorities. It shall be composed of the following:
