RESOLUTION NO. 2018 – 09

RESOLUTION TRANSFERRING THE DATE OF THE CELEBRATION OF SABUTAN FESTIVAL FROM MARCH 20 - 22 OF EVERY YEAR TO JULY 19 - 21 BEGINNING CALENDAR YEAR 2019.

WHEREAS, during the Consultative Meeting of all stakeholders held at the SB Session Hall last March 26, 2018, it was unanimously approved by the August Body to transfer the date of the celebration of Sabutan Festival from March 20 - 22 every year to July 19 - 21 beginning Calendar Year 2019;


NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan members present in Session assembled, be it;
