**RESOLUTION NO. 2019 -15**

**RESOLUTION APPROVING THE TEN-YEAR ECOLOGICAL SOLID WASTE MANAGEMENT PLAN (2018-2027) OF THE MUNICIPALITY OF PALANAN, ISABELA.**

**WHEREAS**, Executive Order No. 36, series of 2018 reorganized the Municipal Ecological Solid Waste Management Board (MSWMB) and its Technical Working Group (TWG) purposely to work for the preparation of the Ten -Year SWMP of this municipality;

**WHEREAS**, the LGU in coordination with the Environmental Management Bureau (EMB) Regional Office No. 02. The lead agency in the implementation of Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000 has formulated the municipality's Ecological Solid Waste Management Plan;

**WHEREAS**, R.A. 9003 mandates all LGUs to segregate waste-at-source, provide Material Recovery Facility as storage for collected and segregated waste and dispose residual materials in environmentally accepted disposal facilities;

**WHEREFORE**, upon motion of Honorable Jimmy B. Gonzales, Sangguniang Bayan Member and unanimously approved by the August Body;

**RESOLVED**, to approve the Ten-Year Ecological Solid Waste Management Plan (2018-2027) of the Municipality of Palanan, Isabela;

**RESOLVED FINALLY**, to furnish a copy of this resolution to DENR -EMB Region 02 for their information, favorable consideration and approval. Likewise, to furnish copies of the same to the Office of the Sangguniang Panlalawigan thru **Hon. Antonio "Tonypet" T. Albano**, Provincial Vice-Governor/Presiding Officer for their information and reference.
