RESOLUTION NO. 2019 - 35

RESOLUTION RECONSTITUTING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) PURSUANT TO SECTION 43 (a) OF RA NO. 6975, OTHERWISE KNOWN AS THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT ACT OF 1990 AS AMENDED BY TITLE IX SECTION 66 OF RA NO. 8551 OTHERWISE KNOWN AS AN ACT PROVIDING FOR THE REFORM AND RE-ORGANIZATION OF THE PHILIPPINE NATIONAL POLICE AND FOR OTHER PURPOSES, AMENDING CERTAIN PROVISIONS OF REPUBLIC ACT No. 6975 ENTITLED "AN ACT ESTABLISHING THE PHILIPPINE NATIONAL POLICE UNDER A RE-ORGANIZED DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, AND FOR OTHER PURPOSES"

WHEREAS, Section 43 (a) of Republic Act No. 6975, as amended by Title IX, Section 66 of Republic Act No. 8551 provides among others the Creation of the People's Law Enforcement Board (PLEB). The Sangguniang Panglungsod/Bayan shall create such number of People's Law Enforcement Board (PLEB) as may be necessary: Provided, that there shall be at least one (1) PLEB for every five (500) City or Municipal Police Personnel and for each Legislative District in a city;

WHEREAS, Section 66 (b) of Republic Act 8551, provides that the PLEB shall be the central receiving entity for any citizen's complaint against the officers and members of the PNP. Subject to the provisions of Section 41 of RA 6975, the PLEB shall take cognizance of or refer the complaint to the proper disciplinary or adjudicatory authority within three (3) days upon the filing of the complaint;

WHEREAS, as mandated by Rule 11 Section 4 of NAPOLCOM MC 2016-002, that the Sangguniang Panglungsod /Bayan shall pass a Resolution formally organizing the PLEB, a copy thereof shall immediately be submitted to the City/Municipal Mayor who shall, within five (5) days from receipt of the same, issue the appropriate Executive Order adopting the resolution of the Sanggunian concerned. A copy of said Executive Order shall be furnished the NAPOLCOM Regional Office within Ten (10) days from issuance;

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan members in session assembled; Be it as it is;

RESOLVED, AS IT IS HEREBY RESOLVED, to reconstitute the People's Law Enforcement Board (PLEB) for the Municipality of Palanan in pursuance of and subject to the provisions of Section 4 of Rule 11, Memorandum Circular 2016-002 of the National Police Commission.

RESOLVED FINALLY, to forward copies of this Resolution to the Department of Interior and Local Government, Region II and the National Police Commission, Region 02, Tuguegarao City, Cagayan for their information and guidance. Likewise, to furnish copies of the same to the Office of the Sangguniang Panlalawigan thru **Hon. Faustino G. Dy, III**, Provincial Vice-Governor/Presiding Officer for their information and reference.
