**A RESOLUTION APPROVING THE GRANT OF ALLOWANCE AND HONORARIUM TO BARANGAY VAW DESK IN PERFORMING THEIR FUNCTIONS IN THE MUNICIPALITY OF PALANAN, ISABELA**

**WHEREAS**, under Section 447 (a) of the Local Government Code of 1991, the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the said Code;

**WHEREAS**, the provision of incentives and awards to Barangay Violence Against Women (BVAW) Desk may be considered among the programs of the Municipal Government for the welfare of the barangay;

**WHEREAS**, the municipality has seventeen (17) Barangay VAW Desk promoting and protecting the rights of children and women pursuant to the provisions of RA 9262;

**WHEREAS**, Barangay VAW Desks are essential in providing support services, such as access to legal services, counseling, referrals and/or rehabilitation programs to abused women and children;

**WHEREAS**, their position is a voluntary position in the barangay, that does not have wages and salaries in return of their functions;

**WHEREAS**, they attend meetings and submit quarterly reports to Municipal Social Welfare and Development Office, coordinate with and refer cases to government agencies, non-government organizations (NGOs), institutions, and other service providers as necessary; address other forms of abuse committed against women, especially senior citizens, women with disabilities and other marginalized groups; lead advocacies on the elimination of VAWC in the community; and perform other related functions as may be assigned;

**WHEREAS**, it could be taken into consideration allowing the 17 Barangay VAW Desk to receive allowance or honorarium for the basic necessities in performing their functions basically for their transportation or meals;

**WHEREAS**, possible sources of fund for their honorarium or allowance shall be allocated under the 5% Gender and Development Fund;

**NOW THEREFORE**, upon motion of Honorable Pacita Mona Q. Atanacio, Sangguniang Bayan Member and was approved by the body; Be it as it is;

**RESOLVED, AS IT IS HEREBY RESOLVED**, to propose the grant of allowance and honorarium to Barangay VAW Desk in performing their functions in the Municipality of Palanan, Isabela.

**RESOLVED FURTHER**, to forward copies of this Resolution to the Office of the Municipal Mayor, Municipal Social Welfare and Development Office and other offices concerned for their information and guidance.
