RESOLUTION NO. 2019 – 79

A RESOLUTION ADOPTING THE REVISED STANDARDS IN PROCESSING BUSINESS PERMITS AND LICENSES USING THE UNIFIED BUSINESS APPLICATION IN PALANAN, PROVINCE OF ISABELA.

WHEREAS, the Constitution mandates that the government shall promote quality of life of the people;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that the local government units shall pursue undertaking to enhance economic prosperity, among other concerns;

WHEREAS, Section 2 of Republic Act No. 9485, “Anti-Red Tape Act of 2007” which provides that the State shall establish effective practice aimed at the prevention of graft and corruption in government, and shall likewise take appropriate measure to promote transparency in each agency with regard to the manner of transacting with the public, which shall encompass a program for adoption of simplified procedures that will reduce tape and expedite transactions in government.

WHEREAS, DILG and DTI Joint Memorandum Circular No. 01, Series of 2016 dated 30 August 2016 provides the Revised Standards in Processing Business Permits and Licenses in all cities and municipalities;

WHEREAS, a single or unified business application form shall be used in processing new applications for business permits and business registrant needed by various local government departments including BFP;

WHEREAS, the unified form shall be made available using various channels for dissemination and make available for download either in the municipal official website, in “fillable format” which can be filled up electronically and/or printed for submission or uploaded if the municipality has an online mechanism for submission of permit applications;

NOW THEREFORE, upon motion of **Honorable Michael John D. Bernardo, Sangguniang Bayan Member** and unanimously approved by the Sangguniang Bayan Members present; Be it as it is;

HEREBY RESOLVED, as it is **HEREBY RESOLVED**, to adopt the Revised Standards in Processing Business Permits and Licenses Using the Unified Business Application in the Municipality of Palanan, Isabela.
