**RESOLUTION NO. 2019 – 85**

**A RESOLUTION FORMALLY ACCREDITING PALANAN CHILD DEVELOPMENT WORKER'S ASSOCIATION OF THE MUNICIPALITY OF PALANAN, ISABELA**

**WHEREAS**, Section 34 of the Local Government Code provides that the Local Government Units (LGUs) shall promote the establishment and operation of People and Non- Government Organizations (NGOs) to become active partners in the pursuit of Local Autonomy;

**WHEREAS**, pursuant to Section 108 of the Local Government Code, the Local Sanggunian shall accredit said POs and NGOs for purposes of their representation to Local Special Bodies and they shall be properly organized with demonstrated capacity to promote the public interest and with identified leadership, membership and structure;

**WHEREAS**, the accreditation of the following Civil Society Organizations having complied with all the requirements for accreditation as provided by law and pertinent guidelines on Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies pursuant to DILG MC No. 2019-72, dated May 22, 2019, to wit:
