RESOLUTION NO. 2019 – 87

A RESOLUTION FORMALLY RECOGNIZING DIMASARI TRICYCLE DRIVERS AND OPERATORS ASSOCIATION OF BARANGAY DIMASARI, PALANAN, ISABELA.

WHEREAS, Section 34 of the Local Government Code provides that the Local Government Units (LGUs) shall promote the establishment and operation of People and Non- Government Organizations (NGOs) to become active partners in the pursuit of Local Autonomy;

WHEREAS, pursuant to Section 108 of the Local Government Code, the Local Sanggunian shall recognize said POs and NGOs for purposes of their representation to Local Special Bodies and they shall be properly organized with demonstrated capacity to promote the public interest and with identified leadership, membership and structure;
