A RESOLUTION CONFIRMING THE DISPOSAL OF LGU PROPERTIES AND OTHER ASSETS THRU PUBLIC AUCTION OF THE MUNICIPAL GOVERNMENT OF PALANAN, ISABELA

WHEREAS, pursuant to COA Circular No. 89-296, dated January 27, 1989, mandates the guidelines on the divestment or disposal of property and other assets of national government agencies and instrumentalities, local government units and government-owned or controlled corporations and their subsidiaries;

WHEREAS, pursuant to existing laws, the full and sole authority and responsibility for the divestment or disposal of property and other assets owned by the local government unit shall be lodged in the heads of department of the local government unit;

WHEREAS, conformably to the existing state policy, the divestment or disposal of government property as recommended by the Commission on Audit assigned in this municipality shall be undertaken thru public auction;

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan Members present in Session assembled; Be it as it is;

RESOLVED, AS IT IS HEREBY RESOLVED, to confirm the disposal of LGU properties and other assets thru public auction of the Municipal Government of Palanan, Isabela.
