RESOLUTION NO. 2020 – 006

A RESOLUTION CREATING THE OFFICE OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER (MDRRMO), DEFINING ITS DUTIES AND RESPONSIBILITIES AND FOR OTHER PURPOSES

WHEREAS, R.A. 7160, Section 3 (b) states that there shall be established in every LGU an accountable, efficient and dynamic organizational structure and operating mechanism that will meet the priority needs and survival requirements of its communities;

WHEREAS, R.A. 10121 also known as the "Philippines Risk Reduction and Management Act of 2010" was created by 14th Congress of the Philippines;

WHEREAS, R.A. 10121 Section 12 states that there shall be an established Local Risk Reduction Management Office (LDRRMO) in every Province, City or Municipality, which shall be responsible for letting the directions, development, implementation and coordination of disaster management programs within their territorial jurisdiction;

WHEREAS, it is the declared policy of the Municipality to uphold, adopt and incorporate people's constitutional right to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the Municipality's institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including impacts of climate change;

WHEREAS, the Municipal Government seeks to ensure the continued, effective response to emergencies in collaboration with the national, foreign government and agencies sector;

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan Members present in Session assembled; Be it as it is:

RESOLVED, AS IT IS HEREBY RESOLVED, to create the Office of the Municipal Disaster Risk and Reduction Management Officer (MDRRMO), defining its duties and responsibilities and for other purposes.

RESOLVED FINALLY, to furnish copy of this Resolution to all concerned offices of the Local Government Unit of Palanan, Isabela for their information and appropriate action. Likewise, to furnish copies of this Resolution to the *Office of the Civil Service Commission, Provincial Field Office, CSC Capitol Site, Alibagu, City of Ilagan and Provincial Budget Office, Capitol, Alibagu, City of Ilagan* for their information and reference.
