**RESOLUTION NO. 2020 - 007**

**A RESOLUTION CREATING THE OFFICE OF THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICER (MENRO), DEFINING ITS DUTIES AND RESPONSIBILITIES AND FOR OTHER PURPOSES**

**WHEREAS**, R.A. 7160, Section 3 (b) states that there shall be established in every local government unit an accountable, efficient, and dynamic organizational structure and operating mechanisms that will meet the priority needs and service requirements of its communities;

**WHEREAS**, under Section 3 (i) states that the Local Government Units shall share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction, subject to the provisions of R.A. 7160 and national policies;

**WHEREAS**, CSC Memorandum Circular No. 19, series of 1992 provides the guidelines and standards in the establishment of Organizational Structures and Staffing Patterns in Local Government Units;

**NOW THEREFORE**, upon unanimous accord of all the Sangguniang Bayan Members present in Session assembled; Be it as it is;

**RESOLVED, AS IT IS HEREBY RESOLVED**, to create the Office of the Municipal Environment and Natural Resources Officer (MENRO), defining its duties and responsibilities and for other purposes.

**RESOLVED FINALLY**, to furnish copy of this Resolution to all concerned offices of the Local Government Unit of Palanan, Isabela for their information and reference. Likewise, to furnish copies of this Resolution to the *Office of the Civil Service Commission, Provincial Field Office, CSC Capitol Site, Alibagu, City of Ilagan and Provincial Budget Office, Capitol, Alibagu, City of Ilagan* for their information and appropriate action.
