RESOLUTION NO. 2020-010

A RESOLUTION ADOPTING MEASURES TO CONTROL THE SPREAD OF AFRICAN SWINE FEVER (ASF) WITHIN OUR AREA OF JURISDICTION

WHEREAS, DILG Secretary, Eduardo M. Ano issued an Advisory dated September 25, 2019, enjoining all Local Government Units to implement measures to control the spread of African Swine Fever (ASF) due to the rapidly increasing number of ASF case in the Philippines affecting pigs and wild boars and to contain the outbreak in our area of jurisdiction;

WHEREAS, this LGU shall monitor and ensure that no live hogs to enter with questionable origin such as but not limited to (1) Putting up a 24/7 animal quarantine checkpoints in various entry points (2) Ensuring that transport vehicles bearing hogs was checked if it has a veterinary health certificate and shipping permit;

WHEREAS, intensify monitoring of meat retailers and suppliers to ensure that pork products sold in the market have National Meat Inspection Service seals;

WHEREAS, monitor and inspect piggeries for affected live hogs and swine in this Municipality;

WHEREAS, the Municipal Government of Palanan shall raise public awareness on measures to help reduce cases of ASF outbreak by reporting presence of sick pigs to the proper departments or offices and remind the public to avoid dumping of carcasses in waterways and to coordinate in the proper way of disposing dead animals and in cleaning and disinfecting the environs of infected pig;

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan Members in Session assembled; Be it as it is;

RESOLVED, AS IT IS HEREBY RESOLVED, to adopt measures to control the spread of African Swine Fever (ASF) within our area of jurisdiction.

RESOLVED FINALLY, to forward copies of this Resolution to the Office of the Municipal Agriculture, Municipal Health Office and Office of the Municipal Mayor for their information and appropriate action. Likewise to furnish copies of the same to Office of the DILG-Provincial Office, Alibagu, City of Ilagan, Isabela thru Ms. Rubyrose Angelie G. Baccay, MLGOO, Palanan, Isabela for their information and reference.
