RESOLUTION NO. 2020 - 019

RESOLUTION GRANTING A LOYALTY AWARD TO ALL MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF PALANAN, ISABELA

WHEREAS, pursuant to CSC MC No. 06, series of 2002, revising the Policies on the Grant of Loyalty Award, these policies were formulated to recognize the continuous and satisfactory service rendered in the government by officials and employees for a period of ten (10) years;

WHEREAS, a Loyalty award is granted to all officials and employees of this Local Government Units, who rendered ten (10) years of continuous service and satisfactory service in the government;

WHEREAS, an official or employee who incurred an aggregate of not more than 50 days authorized vacation leave without pay within 10-year period shall be considered as having rendered continuous service for purposes of granting the loyalty award;

WHEREAS, an official or employee who incurred an aggregate of not more than twenty five (25) days authorized vacation leave without pay within the 5-year period may qualify for the 5-year milestone loyalty award;

WHEREAS, the awardee shall receive a *memorabilia/souvenir* as may be provided by the agency and a cash gift of **One Thousand Pesos (P1,000.00)** for every year of service be given to qualified officials or employees,

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan Members present in Session assembled; Be it as it is;

RESOLVED, AS IT IS HEREBY RESOLVED, to grant a Loyalty Award to all Municipal Officials and Employees of the Municipal Government of Palanan, Isabela.

RESOLVED FURTHER, to furnish copy of this Resolution to all concerned offices of the Local Government Unit of Palanan, Isabela for their information, reference and appropriate action.
