**RESOLUTION NO. 2020-060**

**A RESOLUTION GRANTING THE RETIREMENT INCENTIVE TO BARANGAY HEALTH WORKER (BHW) AMOUNTING TO TWENTY THOUSAND (PHP 20,000.00) PESOS IN THE MUNICIPALITY OF PALANAN, ISABELA.**

**WHEREAS**, the 1987 Constitution of the Republic of the Philippines declares that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, the Primary Health Care Approach is recognized as the major strategy towards health empowerment, emphasizing the need to provide accessible and acceptable health services through the participatory strategies such as health education, training of Barangay Health Workers, Community Building and Organizing;

**WHEREAS**, Republic Act No. 7883 otherwise known as “Barangay Health Workers Benefits and Incentives Act of 1995” was enacted to grant benefits and incentives as well as recognizing the vital role of Barangay Health Workers in the country;

**WHEREAS**, the Local Government and its instrumentalities also recognized the rights of Barangay Health Workers to organize themselves, to strengthen and systematize their services to the community and to make a venue for sharing their experiences and for recommending policies and guidelines for the promotion, maintenance and advancement of their activities and services;

**WHEREAS**, Barangay Health Workers are indispensable partners of the local government in the promotion of basic rural health programs and activities;

**WHEREAS**, it is but fitting and proper that Barangay Health Workers be duly recognized and given honorarium and benefits for their selfless sacrifices and dedicated service in serving our locality;

**NOW THEREFORE**, upon unanimous accord of all the Sangguniang Members present; Be it as it is;

**RESOLVED, AS IT IS HEREBY RESOLVED**, to grant the Retirement Incentive to Barangay Health Worker (BHW) amounting to Twenty Thousand Pesos (PHP 20,000.00) in the Municipality of Palanan, Isabela.
