RESOLUTION NO. 2020 – 074

RESOLUTION GRANTING AUTHORITY TO HONORABLE ELIZABETH B. OCHOA, MUNICIPAL MAYOR OF PALANAN, ISABELA, TO PURCHASE A SERVICE VEHICLE TO BE USED FOR GOVERNMENT OPERATIONS AND TRANSACTION OF THIS MUNICIPALITY SUBJECT TO APPLICABLE LAWS ON PROCUREMENT

WHEREAS, a letter request dated August 14, 2020 from Honorable Elizabeth B. Ochoa, Municipal Mayor re: granting authority to purchase a service vehicle to be used for government operations and transactions of this local government unit was submitted for this Body's appropriate action;

WHEREAS, the request is one of the requirements called for by DILG Memorandum Circular No. 2014-155, which provides the Guidelines on Motor Vehicle Acquisitions by the LGUs;

WHEREAS, this August Body finds the necessity to purchase a service vehicle subject to applicable laws on procurement in order to hasten mobility of government operations, activities and transactions;

WHEREAS, if favorably acted upon, it will facilitate the LGU's intent to purchase such service vehicle;

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan Members present; Be it as it is;

RESOLVED, AS IT IS HEREBY RESOLVED, to grant authority to Honorable Elizabeth B. Ochoa, Municipal Mayor of Palanan, Isabela, to purchase a service vehicle to be used for government operations and transactions of this Municipality subject to applicable laws on procurement.
