RESOLUTION NO. 2020-102

RESOLUTION GRANTING AUTHORITY TO HONORABLE ELIZABETH B. OCHOA, MUNICIPAL MAYOR OF PALANAN, ISABELA, TO PURCHASE ONE (1) UNIT PICK-UP MOTOR VEHICLE FOR EMERGENCY, RESCUE AND RESPONSE OF THIS MUNICIPALITY, SUBJECT TO APPLICABLE LAWS ON PROCUREMENT

WHEREAS, our municipality is geographically isolated from mainland municipalities which can only be reached by light aircrafts and watercrafts;

WHEREAS, the Municipality of Palanan is composed of seventeen (17) barangays of which consist of two (2) urban barangays, four (4) coastal barangays where the accessibility and mobility for emergency, rescue and response shall be catered through the provision of rescue vehicle;

WHEREAS, the purchase of one (1) unit Pick-up Motor Vehicle would significantly contribute to the provision of basic health services more importantly in times of emergency and disaster;


WHEREAS, if favorably acted upon, it will facilitate the LGU's intent to purchase such rescue vehicle;

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan Members present; Be it as it is;

RESOLVED, AS IT IS HEREBY RESOLVED, to grant authority to Honorable Elizabeth B. Ochoa, Municipal Mayor of Palanan, Isabela, to purchase One (1) Unit Pick-up Motor Vehicle for emergency, rescue and response of this Municipality, subject to applicable laws on procurement.
