RESOLUTION NO. 2020-104

A RESOLUTION ADOPTING THE MODIFICATION IN THE POSITION ATTRIBUTES OF NURSE POSITIONS IN THE MUNICIPAL GOVERNMENT OF PALANAN, ISABELA

WHEREAS, Section 32 of Republic Act (RA 9173) or the Philippine Nursing Act of 2002 provides minimum base pay of not lower than Salary Grade (SG)-15 for Nurses working in the public health institutions;

WHEREAS, LBC 2020-4 dated July 17, 2020 is issued to prescribe the rules and regulations on the upgrading of the entry-level of Nurse positions to SG-15, as well as to highlight the administrative procedures in view of the consequential modification in the position attributes of the Nurse items;

WHEREAS, LBC 2020-4 covers all Nurse positions, whether regular, casual, or contractual in nature, full-time or part time, now existing or hereafter created in the national government agencies (NGAs), including SUCs and GOCCs, and in LGUs covered by the Compensation and Position Classification System (CPCS) under Republic Act (RA) No. 6758 or the "Compensation and Position Classification Act of 1989," as amended;

WHEREAS, the position attributes of the following classes of Nurse positions are hereby modified:

FROM	SALARY GRADE	TO	SALARY GRADE
Nurse I	11	Nurse I	15
Nurse II	15	Nurse I	15
Nurse III	17	Nurse II	17
Nurse IV	19	Nurse III	19
Nurse V	20	Nurse IV	20
Nurse VI	22	Nurse V	22
Nurse VII	24	Nurse VI	24


WHEREAS, the new salary rates shall be in accordance with the applicable Salary Grade Schedule adopted by the LGU pursuant to the provisions of Item 6.5 of the Local Budget Circular No. 121 (Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to RA No. 11466) dated January 24, 2020;

NOW THEREFORE, upon unanimous accord of all the Sangguniang Bayan Members present; Be it as it is;

RESOLVED, AS IT IS HEREBY RESOLVED, to adopt the modification in the position attributes of Nurse Positions in the Municipal Government of Palanan, Isabela.

RESOLVED FINALLY, to furnish copies of this Resolution to all offices concerned for their information and reference.
