AN ORDINANCE PROHIBITING SPITTING AND URINATING IN PUBLIC PLACES AND PROVIDING PENALTY FOR VIOLATIONS THEREOF

WHEREAS, the Municipality of Palanan is committed to provide a healthy atmosphere to the residents and passersby and to maintain a clean and sanitary environment;

WHEREAS, the act of spitting and urinating in public places are insulting, offensive and revolting to the public and properties;

WHEREAS, the smell of urine and the sight of sputum in the environment is undoubtedly unhygienic and unsanitary;

WHEREAS, the unsanitary and barbaric acts not only reflect a bad impression on the quality of discipline that we have, it likewise create an unhealthy surrounding that could generate, carry and transfer infectious diseases from one person to another;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Palanan, Isabela in a session assembled; that:

SECTION 1. PROHIBITION. It shall be unlawful and a public nuisance for any person to spit or urinate in public places to which the public has access, which includes any street, road, alley, sidewalks, parks, plaza, parking lots or other vacant public and private properties not owned or controlled by the offender, other such areas open and in full view to the public.

SECTION 2. ENFORCEMENT. The Local PNP, Municipal Health Office, all Barangay Officials, Barangay Tanods and Street Sweepers are hereby authorized to enforce and implement the prohibitions of this Ordinance.

SECTION 3. PENAL PROVISION.

FIRST OFFENSE	A fine of <i>Three Hundred Pesos (P300.00)</i> or <i>One (1) day Community Service</i> ;
SECOND OFFENSE	A fine of <i>Four Hundred Pesos (P400.00)</i> or <i>Three (3) days Community Service</i> .
THIRD OFFENSE	A fine of <i>Five Hundred Pesos (P500.00)</i> or <i>Seven (7) days Community Service</i> .

SECTION 4. SEPARABILITY CLAUSE. If for any reason/s, any part/s or provisions of this Ordinance shall be declared unconstitutional or invalid, other part/s or provision/s hereof not affected shall remain in full force or effect.

SECTION 5. REPEALING CLAUSE. All ordinances, resolutions and executive orders inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take upon approval of this Ordinance.
