AN ORDINANCE ABOLISHING THE FOLLOWING PLANTILLA POSITIONS IN VARIOUS DEPARTMENTS/OFFICES OF THE MUNICIPAL GOVERNMENT OF PALANAN, ISABELA

WHEREAS, Section 7 of Republic Act No. 7160 also known as the "Local Government Code of 1991" provides that " Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 447 of the same Code empowers the Sangguniang Bayan to create positions and determine the powers and duties of officials and employees of the municipality subject to the provisions of pertinent laws and regulations;

WHEREAS, there is a need to abolish various plantilla positions in lieu of the creation of new position items in the different offices of this Local Government Unit with the end view of bringing beneficial reform in the Municipality;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Palanan, Isabela in a session assembled that:

SECTION 01. The following Plantilla Positions under the different offices of the Municipal Government of Palanan, Isabela is hereby abolished, to wit:

POSTION (S)	- SALARY GRADE	OFFICE/DEPARTMENT
INFORMATION OFFICER III	SG 18	Office of the Municipal Mayor
DAY CARE WORKER I	SG 6	Municipal Social Welfare and Development Office
VETERINARIAN I	SG 13	Office of the Municipal Agriculturist
GENERAL SERVICES OFFICER	SG 24	General Services Office
ADMINISTRATIVE ASSISTANT I	SG 7	Office of the Municipal Accountant

SECTION 02. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 03. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 04. EFFECTIVITY. This ordinance shall take effect on January 1, 2023.
