AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE AIDE VI - SALARY GRADE 6 (CASUAL APPOINTMENT) IN OFFICE OF THE MUNICIPAL TREASURER OF THE LOCAL GOVERNMENT UNIT OF PALANAN, ISABELA AND APPROPRIATING FUNDS THEREOF.

WHEREAS, the Local Chief Executive requested the creation of the said position under the Office of the Municipal Treasurer of the Municipal Government of Palanan, Isabela;

WHEREAS, Section 447 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" empowers the Sangguniang Bayan to create positions and determine the powers and duties of officials and employees of the municipality subject to the provisions of pertinent laws and regulations;

WHEREAS, there is a need for the creation of **Administrative Aide VI in the Office of the Municipal Treasurer** with the end view of bringing beneficial reform in the Municipality;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Palanan, Isabela in a session assembled, that:

SECTION 01. The position of Administrative Aide VI- SG 6 (Casual Appointment) is hereby created in the Office of the Municipal Treasurer and appropriating the necessary funds thereof.

SECTION 02. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 03. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 04. EFFECTIVITY. This ordinance shall take effect on January 1, 2023.
