AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2010-004, SERIES OF 2010, PROHIBITING MINORS TO DRIVE MOTOR VEHICLES AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREFOR.

Be it ordained by the Sangguniang Bayan of Palanan, Isabela in a session assembled that:

SECTION 1. DECLARATION OF POLICY. The Local Government Code mandates the power of Local Government Unit to regulate all forms of transportation vehicles within its territorial jurisdiction to protect public interest and to promote the safety and welfare of the people.

SECTION 2. PROHIBITED ACTS.

- 2.1. It is prohibited for minors to drive any kind of motor vehicle pursuant to the provisions of RA 9344 (Juvenile Justice and Welfare Act);
- 2.2. Parents/guardian and owners who tolerate minors to drive motor vehicle.

SECTION 3. IMPLEMENTATION. The minors who are caught violating this ordinance shall be brought to the Office of the Municipal Social Welfare and Development Officer to be released to the custody of their parents/guardian. Further, adopting the provisions of R.A. 7610 otherwise known as, "Special Protection of Children Against Abuse, Exploitation and Discrimination Act", the process flow chart in handling cases of Children at Risk (CAR) and Children in Conflict with the Law (CICL).

SECTION 4. IMPLEMENTING AGENCIES. The Members of the Philippine National Police, MSWD Office, all Barangays Officials and Barangay Tanods shall turn-over the minor individual to the Office of the Municipal Social Welfare and Development Officer. The Local PNP shall take custody of the motor vehicle for safe-keeping, and shall be released only upon payment of the corresponding fine paid by the parent/guardian and owner of motor vehicle.

SECTION 5. PENALTIES. Owner and parent/guardian of minors who tolerate to drive motor vehicles shall be penalized by:

- 1st Offense** : A fine of **Five Hundred Pesos (Php 500.00)**;
- 2nd Offense** : A fine of **One Thousand Pesos (Php1,000.00)**;
- 3rd Offense** : A fine of **Two Thousand Five Hundred Pesos (Php 2,500.00)**.

Fifty (50%) or one-half of the fines/penalties imposed to violators of which shall accrue to the Palanan Police Force to defray the cost of operation, implementation and surveillance. The **Municipal Treasury Office** shall prepare statement of collections/receipts as a result of fines/penalties imposed thereof.

SECTION 6. PAYMENT. Payment shall be made to the Barangay Treasurer where the violation is committed or at the Office of the Municipal Treasurer, as the case maybe.

SECTION 7. FUNDING. An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance shall be sourced out from the General Fund of this Local Government Unit.

SECTION 8. SEPARABILITY CLAUSE. If any provision of this ordinance found to be inconsistent with any law, other provision/s or part/s thereof not so affected shall remain in full force and effect.

SECTION 9. REPEALING CLAUSE. All ordinances, rules, regulations, issuances or parts thereof, in conflict with, or contrary to, the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.
