AN ORDINANCE PROHIBITING THE CONSUMPTION OR DRINKING OF ALCOHOLIC BEVERAGES IN ALL PUBLIC PLACES IN THE MUNICIPALITY OF PALANAN, ISABELA.

Be it ordained by the Sangguniang Bayan of Palanan, Isabela in a session assembled that:

SECTION 1. TITLE. This Ordinance shall be known as the "**Ban on Drinking Alcoholic Beverages in All Public Places Ordinance**".

SECTION 2. DECLARATION OF POLICY. It is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them.

SECTION 3. REGULATED ACTS.

3.1. No person shall consume/drink any kind of intoxicating beverages such as beer, wines, and other distilled spirits (other than denatured alcohol) in any place, fixed or mobile, accessible or open to the public, or places for collective use regardless of ownership or right to access, including but not limited to, restaurants, convenience stores, sari-sari stores, carinderias, markets, public streets, walkways/sidewalks, parkway, alley parks, playgrounds, plaza, transportation terminals.

3.2. The consumption of alcoholic drinks or liquors is allowed provided that it is done inside the house only or in their private/enclosed backyard;

3.3. No one is allowed to go outside of their residences under the influence of intoxicating beverages;

3.4. Curfew hours will be followed in the purchase and sale of liquors, thus, no one shall be allowed to purchase/sell liquor from **9:00 P.M. to 5:00 A.M.**

SECTION 4. ENFORCEMENT AND IMPLEMENTATION. The Philippine National Police Force, Barangay Officials and Barangay Tanods shall strictly enforce the provisions of this Ordinance.

SECTION 5. PENALTIES. Any person of legal age and business entity/ies found violating this Ordinance shall be penalized with the following fines, to wit:

First Offense : Fine of ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) or three (3) days community service ;

Second Offense : Fine of TWO THOUSAND PESOS (P2,000.00) or five (5) days community service; and

Third Offense : Fine of TWO THOUSAND FIVE HUNDRED PESOS (P 2,500.00) or ten (10) days community service for the buyer/purchaser and revocation of Mayor's Permit for One (1) year for the establishments caught to violate this Ordinance.

Fifty (50%) or one-half of the fines/penalties imposed to violators of which shall accrue to the Palanan Police Force to defray the cost of operation, implementation and surveillance. The **Municipal Treasury Office** shall prepare statement of collections/receipts as a result of fines/penalties imposed thereof.

SECTION 6. FUNDING. An initial funding to defray expenses incidental to the implementation of this Ordinance shall be sourced out from the MOOE of the Office of the Municipal Mayor of this Local Government Unit.


SECTION 7. SEPARABILITY CLAUSE. If any part or provision of this Ordinance is held invalid or unconstitutional, other provisions not affected thereby shall remain in force and effect.

SECTION 8. REPEALING CALUSE. All ordinances, rules and regulations, or parts thereof in conflict, or inconsistent herewith, are hereby repealed, amended or modified accordingly.

SECTION 9. EFFECTIVITY. This Ordinance shall take effect after fifteen (15) days from the date a copy hereof is posted in a bulletin board at the entrance of the Municipal Building and in at least two (2) conspicuous places in the municipality.
