**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2011-08, SERIES OF 2011, PRESCRIBING PENALTIES FOR MOTOR VEHICLE VIOLATIONS AND TRAFFIC OFFENCES AND FOR OTHER PURPOSES.**

**BE IT ORDAINED** by the Sangguniang Bayan of Palanan, Isabela in a session assembled that:

**SECTION 1. DECLARATION OF POLICY.** The Local Government Code mandates the power of Local Government Unit to regulate all forms of transportation vehicles within its territorial jurisdiction to protect public interest and to promote the health, comfort, safety and welfare of the people.

**SECTION 2. PENALTIES.** There is hereby prescribe penalties for the following motor vehicle violations and traffic offences, to wit:

**Fifty (50%) or one-half** of the fines/penalties imposed to violators of which shall accrue to the Palanan Police Force to defray the cost of operation, implementation and surveillance. The **Municipal Treasury Office** shall prepare statement of collections/receipts as a result of fines/penalties imposed thereof.

**SECTION 3. ENFORCEMENT.** The Deputized Palanan Police Force with the assistance of Barangay Officials and Barangay Tanods are hereby ordered to strictly implement the provisions of this ordinance and apprehend violators hereof. The Local PNP shall take custody of the motor vehicle for safekeeping and shall be released only upon payment of the prescribed fine/penalty and they shall maintain a logbook for monitoring and records purposes.

**SECTION 4. POSTING OF BILLBOARD AND SIGNAGES.** The LGU through the Office of the Municipal Engineer is hereby task to put-up billboard/signage in conspicuous places in the municipality to notify the public of the restrictions, sanctions and penalties provided in this ordinance.

**SECTION 5. FUNDING.** An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance shall be sourced-out from the General Fund of this Local Government Unit.

**SECTION 6. SEPARABILITY CLAUSE.** If any provision of this ordinance found to be inconsistent with any law, other provision/s or part/s thereof not so affected shall remain in full force and effect.

**SECTION 7. REPEALING CLAUSE.** All ordinances, rules, regulations, issuances or parts thereof, in conflict with, or contrary to, the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

**SECTION 8. EFFECTIVITY CLAUSE.** This Ordinance shall take effect immediately upon its approval.
