AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2021-097, SERIES OF 2021, ESTABLISHING THE 2023 FARE RATES FOR MOTORIZED TRICYCLES AND KULONG-KULONG FOR HIRE IN THE MUNICIPALITY OF PALANAN, PROVINCE OF ISABELA.

BE IT ORDAINED by the Sangguniang Bayan of Palanan, Isabela in a session assembled that:

SECTION 1. REGULATED FARE RATES. The new fare rates for Tricycles and Kulong-Kulong-for-hire operating in the Municipality of Palanan, Province of Isabela shall be as herein prescribe:

SECTION 2. PRINTING AND POSTING OF FARE/CARGO MATRIX. The Office of the Municipal Treasurer is responsible for the printing and posting of the Fare Matrices and Cargo Rates on all Tricycles and Kulong-Kulong for hire in this Municipality.

SECTION 3. IMPLEMENTERS. The Punong Barangay and Members of the Philippine National Police are hereby directed to implement and shall issue Citation Ticket to any violator pursuant to the provisions under Section 1 of this Ordinance.

SECTION 4. PENALTY CLAUSE. Any person who violates this Ordinance shall be fined of **Two Thousand Five Hundred Pesos (P2,500.00)**.

Fifty (50%) or one-half of the fines/penalties imposed to violators of which shall accrue to the Palanan Police Force to defray the cost of operation, implementation and surveillance. The **Municipal Treasury Office** shall prepare statement of collections/receipts as a result of fines/penalties imposed thereof.

SECTION 5. A *Citation Ticket* shall be issued to the person liable for any violation of this Ordinance upon finding of the violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Office of the Municipal Treasurer for payment of fine and monitoring purposes.

SECTION 6. SEPARABILITY CLAUSE. If for any reason, any provision, portion or part of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 7. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 8.EFFECTIVITY. This Ordinance shall take effect upon its approval.
