MUNICIPAL ORDINANCE NO. 2023-16-137

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2019-04, SERIES OF 2019, DECLARING CERTAIN SITES, AND HERITAGE, AS CULTURAL PROPERTIES AND RECOGNIZING ITS SIGNIFICANCE IN THE CULTURAL IDENTITY OF THIS MUNICIPALITY.

BE IT ORDAINED by the Sangguniang Bayan in its Regular Session, duly assembled, that:

Section 1. Title. This Ordinance shall be known and be referred to as "**CULTURAL PROPERTIES ORDINANCE**".

Section 2. Basis of Enactment.

- 1) Republic Act No. 10066, also known as the "National Heritage Act of 2009"; and
- 2) Department of the Interior and Local Government (DILG) and National Commission for Culture and the Arts (NCCA) Joint Memorandum Circular No. 2018-01 dated October 09, 2018;

Section 3. Definition of Terms.

3.1. Cultural Property – refers to all products of human creativity by which a people and a nation reveal their identity, including churches, mosques and other places of religious worships, schools and natural history specimen and sites, whether public or privately-owned movable or immovable and tangible or intangible;

Section 4. Declaration of Cultural Properties. There is hereby declared as **PALANAN CULTURAL PROPERTIES**, the following list of intangible, tangible and immovable properties in this Municipality, to wit:

Section 6. Effectivity. This Ordinance shall take effect immediately upon approval.
