**MUNICIPAL ORDINANCE NO. 2021-096**

**AN ORDINANCE PROHIBITING THE TYING AND DOCKING OF MOTORBOAT AT THE EROSION CONTROL STRUCTURE LOCATED AT BARANGAY DICABISAGAN WEST, PALANAN, ISABELA AND PRESCRIBING PENALTIES FOR VIOLATION THEREFOR**

**WHEREAS**, RA 7160 provides that Local Government Units shall exercise its powers expressly granted, and those that are necessarily implied therefrom, which are necessary and essential to the promotion of the general welfare of its inhabitants;

**WHEREAS**, the tying and docking of motorboats will immensely damage the Gabion Type Erosion Control Structure along the Pinacanauan Riverbank and the end portion of Palanan Airport;

**WHEREAS**, it is imperative to ensure public safety, protection and preservation of eroded portion of the riverbank and impose penalties for acts, which endanger the environment;

**NOW THEREFORE**, Be it ordained by the Sangguniang Bayan of Palanan, Isabela in session assembled that:

**SECTION 1. REGULATED ACTS.**

- a. It is hereby prohibited to tie/dock motorboat at the Erosion Control Structure located at Pinacanauan Riverbank, Barangay Dicabisagan West, Palanan, Isabela;
- b. Motorboat operators shall dock to the designated areas for landing and docking.
- c. Confiscated motorboat shall be at the custody of Palanan Police Station and shall in turn release upon payment of corresponding penalty hereof.

**SECTION 2. IMPLEMENTERS.** The Barangay Officials and Barangay Tanods are hereby directed to implement the provisions of this Ordinance with the assistance of PNP Members. The Municipal or Barangay Treasurer shall collect the prescribed penalties and issue corresponding receipt as proof of payment.

**SECTION 3. PENALTY CLAUSE.** Any person who violates the provision of this Ordinance shall be penalized a fine of:

- 1<sup>st</sup> *Offense* : Five Hundred Pesos (P500.00);
- 2<sup>nd</sup> *Offense* : One Thousand Pesos (P1,000.00) and
- 3<sup>rd</sup> *Offense*: Two Thousand Pesos (P2,000.00) and confiscation of motorboat ;

**SECTION 6. EFFECTIVITY CLAUSE** This Ordinance shall take effect upon its approval
