**ORDINANCE NO. 2017-001
AN ORDINANCE CREATING THE ADMINISTRATIVE BOARD IN THE
MUNICIPALITY OF PALANAN, ISABELA

WHEREAS, the Municipality of Palanan has committed itself o its share in the all-out campaign to combat/eradicate the menace of Drug Addiction prevailing in almost all parts of the country including the Municipality of Palanan;

WHEREAS, pursuant to Section 52, Article VII of RA 9165, the Administrative Board shall hear and act on complaints regarding public nuisance;

NOW THEREFORE, be it ordained by the Sangguniang Bayan in a Regular Session assembled that;

Section 1- Effective immediately, the Administrative Board of the Municipality of Palanan, Isabela be created.
