MUNICIPAL ORDINANCE NO. 2017 - 05

AN ORDINANCE PROVIDING FOR CHILD SURVIVAL, DEVELOPMENT, PROTECTION, SECURITY AND PARTICIPATION AND ESTABLISHING A COMPREHENSIVE CHILDREN'S SUPPORT SYSTEM IN PALANAN, ISABELA AND FOR OTHER PURPOSES OTHERWISE KNOWN AS THE "CHILD'S WELFARE CODE OF PALANAN, ISABELA".

Be it ordained by the Sangguniang Bayan of the Municipality of Palanan, Province of Isabela in Session assembled, that:

ARTICLE I

TITLE, POLICY, PRINCIPLES AND DEFINITION OF TERMS

Section 01. TITLE

This Ordinance shall be known as **An Ordinance providing for Child Survival, Development, Protection and establishing a comprehensive Children's support system in Palanan, Isabela and for Other Purposes otherwise known as the "CHILD'S WELFARE CODE OF PALANAN, ISABELA".**

Section 02. DECLARATION OF PRINCIPLES AND POLICIES

Palanan, Isabela has been declared as a Child Friendly Municipality. It is the policy of the Municipal Government that the rights of children for survival, protection, participation and development of their potentials must be given priority. It shall support the role of the family providing for children and promote the efforts of parents, other childcare and development workers, PO's and NGO's and the community to nurture and care for children from infancy especially during the earliest stage of childhood up to adolescence. Consistent herewith the Municipal Government shall endeavor to strengthen the establishment of comprehensive children and family support system in the entire Municipality and enjoin all the efforts of both public PO's and NGO's and the Private Sector to achieve the goals for the protection, participation and development.

(Php 30,000.00) shall be appropriated initially to implement the Provisions of this Code which appropriation shall be sourced from the General Fund.

ARTICLE X

FINAL PROVISIONS

Section 44. IMPLEMENTING RULES AND REGULATIONS

Within Six (6) months after the approval of the Code, the Local Chief Executive as assisted by the Offices of the Provincial Attorney, and the Provincial Prosecutor shall formulate and issue appropriate Rules and Regulations necessary for the efficient and effective implementation of any and all Provisions of this Ordinance.

Such Rules and Regulations shall take effect after Fifteen (15) days following the completion of their Publication in Two (2) local newspaper of general circulation in the Municipality of Palanan and the Province of Isabela.

Section 45. SEPARABILITY CLAUSE

If for any reason a Provision of this Ordinance is declared invalid or unconstitutional, all other Provisions hereof not affected thereby shall continue to be in full force and effect.

Section 46. REPEALING CLAUSE

All Ordinances, Executive Orders, Resolutions and Other Local Memoranda or Rules inconsistent with the Provisions of this Ordinance are hereby repealed or modified accordingly.

Section 47. EFFECTIVELY CLAUSE - This Code shall take effect upon approval and compliance with the mandatory posting and publication requirements prescribed under RA 7160, otherwise known as the Local Government Code.
