MUNICIPAL ORDINANCE NO. 2017 – 08

AN ORDINANCE PRESCRIBING USER’S FEE IN THE NORTHERN SIERRA MADRE NATURAL PARK (NSMNP) WITHIN THE POLITICAL JURISDICTION OF THE MUNICIPALITY OF PALANAN, ISABELA.

Be it ordained by the Sangguniang Bayan in Session assembled that:

SECTION 1 – This Ordinance is known as “Prescribing User’s Fee in the Northern Sierra Madre Natural Park (NSMNP) within the Political Jurisdiction of the Municipality of Palanan, Isabela”;

SECTION 2 - Any person or group of persons who shall visit the **Northern Sierra Madre Natural Park (NSMNP) in Palanan, Isabela**, shall pay the User’s Fee as follows:

1. Local Tourist	Php 100.00/person
2. Foreign Tourist	100.00/person
3. Educational Tour	50.00/person
4. Scientific Research Work (Local)	50.00/person
5. Scientific Research Work (Foreign)	100.00/person

SECTION 3 – All concerned shall register at the Office of the Municipal Mayor upon arrival at Palanan, Isabela, indicating the purpose and duration of travel within the Municipality for reference and record purposes;

SECTION 4 – Payment of **User’s Fee** shall be paid directly at the Office of the Municipal Treasurer upon arrival;

SECTION 5 – **User’s Fee** collected shall be for exclusive for the development of potential Eco-Tourism Spots;

SECTION 6 – SEPARABILITY CLAUSE – If for any reason, any provision, portion or part of this Ordinance found to be inconsistent with any Law, other provisions or part/s thereof not so affected shall remain in full force and effect;

SECTION 7 – REPEALING CLAUSE – All Ordinances, Rules and Regulations or parts thereof, in conflict with, or, contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly;

SECTION 8 – EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon approval.
