Literal Copy of *Municipal Ordinance No. 2019-07* approved by the Sangguniang Bayan of Palanan, Isabela in its Regular Session on *September 2, 2019* held at the Legislative Hall, this Municipality.

MUNICIPAL ORDINANCE NO. 2019- 07

AN ORDINANCE BANNING ILLEGAL CONSTRUCTIONS AND STRUCTURES AND USE OF PUBLIC ROADS, ALLEYS, LANES, SIDEWALKS AND OTHER THOROUGHFARES AND PRECRIBING PENALTY HEREOF.

Be it enacted by the Sangguniang Bayan in Session assembled that:

SECTION 1. REGULATED ACTS. No person shall use any public roads, alleys, lanes, sidewalks and other thoroughfares for private ends and banning illegal constructions and structures hereof;

SECTION 2. DEFINITION OF TERMS.

- Public Roads - includes national, provincial, municipal and barangay roads.
- Alleys - refer to a narrow street, passageway or byway.
- Lanes - refer to a narrow pathway or byway;
- Sidewalks - refer to a narrow pathway at the side of the road intended for the use of pedestrians.
- Thoroughfares - a way or place for passage such as street open at both ends or a main road.

SECTION 3. ENFORCEMENT. The Municipal Engineering Office is hereby ordered to strictly implement and conduct inspection activities as provided in this Ordinance. The Members of the Philippine National Police Force shall assist LGU Officials in apprehending violators in accordance with the provisions of this Ordinance.

SECTION 4. The LGU shall create an Implementation Team that shall conduct inspection on constructions and structures to determine their compliance with the provisions of this Ordinance. Regular inspection and beautification activities shall therefore be conducted at least once every week or simultaneous with other regular inspections and beautification activities done by the LGU.

SECTION 5.FUNDING. The Municipal Government shall appropriate an amount of *One Hundred Fifty Thousand (Php150,000.00) Pesos* every year in the Annual Budget under the MOOE of the Office of the Municipal Engineer in order to achieve an effective and efficient implementation of this Ordinance.

SECTION 6. SUBMISSION OF PERIODIC REPORTS. The LGU Implementation Team shall submit the necessary reports to the Office of the DILG thru the Municipal Local Government Operations Officer, Office of the Municipal Mayor and Sangguniang Bayan Office of this Municipality relative to the status of compliance with the provisions of this Ordinance and pertinent provisions of laws governing road clearing of illegal constructions and structures and relocation activities.

SECTION 7. PENAL PROVISION. Any person who violates any provision of this Ordinance shall be punished by a fine of not more than Two Thousand Five Hundred (P2,500.00) Pesos or imprisonment of not more than six (6) months or both fine at the discretion of the Court.

SECTION 7. A Citation Ticket shall be issued to the persons liable for any violation of this Ordinance upon finding of the violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Barangay Government where the violation was committed to be recorded in the Barangay logbook. Payment of fine shall be made at the Barangay Treasurer or Office of the Municipal Treasurer, as the case maybe.

SECTION 11. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
