MUNICIPAL ORDINANCE NO. 2019-08

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 02-02, SERIES OF 2002 LIMITING THE AGE AND NUMBER OF LARGE CATTLE (CARABAO) BROUGHT OUT OF THIS MUNICIPALITY AND OTHER PURPOSES AND PRESCRIBING PENALTIES FOR VIOLATIONS HEREOF.

Be it enacted by the Sangguniang Bayan in Session assembled:

SECTION 1. There is hereby limit on the age of carabaos to be brought out or transported out from this municipality either for agriculture or meat market, to wit:

- Female - 11 years old
- Male - 7 years old

SECTION 2. The number of large cattle allowed per buyer duly granted with permit to buy by the Office of the Municipal Mayor shall be two (2) heads per buyer quarterly;

SECTION 3. Duty of buyer /owner of large cattle. The buyer shall secure certification of the Punong Barangay or his duly authorize representative where the owner of large cattle resides to certify his true ownership of large cattle in the Office of the Municipal Treasurer. Likewise, the owner of large cattle shall ship out for his personal use, the owner will secure a certification from the Punong Barangay as usual.

SECTION 4. Permit to buy and sell large cattle. No person, partnership, association or entity who shall engage in the business of Buy and Sell of large cattle without first securing a permit for the said purposes from the PNP Provincial Director where it shall conduct such business and the Municipal Treasurer of the place or residence of person, partnership, association, corporation or entity. The permit shall only be valid in such province.

SECTION 5. Clearance for shipment of large cattle. Any person, partnership, corporation or entity desiring to ship or transport large cattle, hides, or most from any province to another shall secure a permit for such purposes from the PNP Provincial Director of the province where the large cattle is registered. Before issuance of the permit herein prescribed, the Provincial Director shall require the submission of the Certificate of Ownership as prescribed in Section 3 hereof. A certification from the Provincial Veterinarian to the effect that such large cattle, hides or most are free from any disease, and such other documents of record as may be necessary. Shipment of large cattle, it hides or most from one municipality to another within the same province may be done upon securing permit from the Municipal Treasurer of the place of origin.

SECTION 6. Presumption of Cattle. Every person having in his procession, control or custody of large cattle shall upon demand by component authorities, exhibit the required document shall be prima facie evidence that the large cattle in his procession, control and custody are the fruits of the crime of the rustling.

SECTION 5. ENFORCEMENT. The Members of the Palanan Police Force, Office of the Municipal Agriculturist, Barangay Officials and Barangay Tanods are hereby ordered to enforce the implementation and issue citation ticket to violators of this Ordinance.

SECTION 6. FUNDING AND APPROPRIATION. The Municipal Government shall appropriate an initial amount of Twenty Thousand (P20,000.00) Pesos every year in its Annual Budget under the MOOE of the Municipal Agriculturist to ensure effective and efficient implementation of this Ordinance.

SECTION 7. PENAL PROVISIONS. Any person (1) convicted of cattle rustling as herein defines shall, irrespective of the value of the large cattle involved, be furnished pursuant to P.D. No. 533 known as " The Anti Large Cattle Rustling Law" of 1974 (2) who violates the provision of Section 1 and 2 hereof shall be punished by fine of Two Thousand Five Hundred (Php 2,500.00) Pesos or imprisonment of seven (7) but not more than fifteen (15) days, or both at the discretion of the court.

SECTION 8. A Citation Ticket shall be issued to the persons liable for any violation of this Ordinance upon finding of the violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Barangay Government where the violation was committed to be recorded in the Barangay logbook. Payment of fine shall be made at the Barangay Treasurer or Office of the Municipal Treasurer, as the case may be.

SECTION 8. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 9. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.
