MUNICIPAL ORDINANCE NO. 2019-10

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO 2014-05, SERIES OF 2014, PRESCRIBING THE CLASSIFICATION OF FISH AND OTHER AQUATIC PRODUCTS AND TO FIX THE CEILING PRICE BY WEIGHT IN KILOGRAMS TO END-CONSUMERS IN THE MUNICIPALITY OF PALANAN, ISABELA AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

Be it enacted by the Sangguniang Bayan Members in Session assembled, that:

SECTION 1. There is hereby prescribed classification of fish and other aquatic products and ceiling price by weight in kilograms to end-consumers:

SECTION 2. REGULATED ACTS. Selling of illegally-caught fishes or fishery/aquatic products by the use of explosives, noxious or poisonous substances, electricity and other deleterious methods of fishing is strictly prohibited by law. The penalty for each violation shall be pursuant to the provisions of *Republic Act No. 8550 known as the "The Philippine Fisheries Code of 1998"*.

SECTION 3. Any fish, fishery/aquatic products on sale in the market or by peddlers found to be unfit for human consumption shall be confiscated and disposed of properly by the Municipal Agriculturist or her duly authorized representative.

SECTION 4. The regulated Price Ceiling herein shall be subject to change anytime upon the recommendations of the *Municipal Price Coordinating Council* insofar as economic consideration of people in general are concerned.

SECTION 5. Disposing and/or selling of Fish and other Aquatic Products beyond the price ceiling and selling other than in the Public Market are strictly prohibited effective upon approval of this Ordinance.

SECTION 6. PUBLIC BILLBOARDS, NOTICES IN THE BARANGAY. Upon effectivity of this Ordinance, the Engineering Office shall put up billboards in conspicuous places in the Municipality to notify the public of the sanctions imposed in this Ordinance.

SECTION 7. ENFORCEMENT. Members of the Palanan Police Force, Municipal Agriculturist Office, Barangay Officials, Barangay Tanods, Members of MPCC or their duly authorized representative and Fish Wardens are hereby ordered to help in the implementation of this Ordinance by apprehending violators and issue citation tickets. Local consumers are hereby directed to report violators to the enforcers/implementers of this Ordinance.

SECTION 8. FUNDING. An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance in the amount of Fifty Thousand (Php 50,000.00) Pesos shall be sourced from the MOOE of the Offices of the Municipal Engineer and Municipal Agriculturist and is hereby allocated every year thereafter.

SECTION 9. PENALTY CLAUSE. All violators will be penalized by a fine of One Thousand (Php 1,500.00) Pesos for the **1st Offense**; Two Thousand (Php 2,000.00) Pesos and confiscation of fish products for sale for the **2nd Offense**; and Two Thousand Five (Php 2,500.00) Pesos, confiscation of fish products for sale and cancellation of Mayor's Permit for the **3rd Offense**.

SECTION 10. A Citation Ticket shall be issued to the persons liable for any violation of this Ordinance upon finding of the violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Barangay Government where the violation was committed to be recorded in the Barangay Logbook. Payment of fine shall be made at the Barangay Treasurer or Office of the Municipal Treasurer, as the case maybe.


SECTION 11. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 12. REPEALING CLAUSE. Any provision of an Ordinance, rules and regulations inconsistent herewith is hereby repealed accordingly.

SECTION 13. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.


