MUNICIPAL ORDINANCE NO. 2019-11

ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2014-04, SERIES OF 2014, FIXING THE PRICES OF BEEF AND CARABEEF IN THE MUNICIPALITY OF PALANAN, ISABELA AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

Be it ordained by the Sangguniang Bayan duly assembled that:

SECTION 1. There is hereby fixed for stricter implementation the following prices of Beef and Carabeef within the Municipality, to wit:

CARABEEF (Kalabaw)

a) Flesh (Laman and Lomo)	140.00/ kilo
b) Special (Papaitan)	140.00/kilo
c) Ribs & Bulalo	120.00/ kilo
d) Bones (Buto-buto)	100.00/ kilo
e) Ordinary Papaitan	120.00/kilo
f) Feet (Paa)	100.00/piece
g) Head (Ulo)	500.00/piece
h) Tail (Buntot)	150.00/kilo
i) Butt & Balls	100.00/kilo

BEEF (Baka)

a) Flesh (Lomo)	180.00/kilo
b) Flesh (Laman)	170.00/kilo
c) Special (Papaitan)	140.00/ kilo
d) Bulalo	130.00/ kilo
e) Ordinary (Papaitan)	110.00/ kilo
f) Feet (Paa)	100.00/piece
g) Tail (Buntot)	200.00/kilo
h) Head (Ulo)	500.00/piece
i) Butt & Balls	150.00/kilo

SECTION 2. All butchered Carabaos and Cows shall only be sold and disposed of at the *Palanan Public Market*. Disposing and/or selling of Beef and Carabeef meat other than in the Public Market is strictly prohibited under this Ordinance.

SECTION 3. Any meat on sale in the market or by peddlers found to be unfit for human consumption shall be disposed of properly by the Municipal Veterinarian/Meat Inspector or his/her duly authorized representative.

SECTION 4. PUBLIC BILLBOARDS, NOTICES IN THE BARANGAY. Upon effectivity of this ordinance, the Engineering Office shall put up billboards in conspicuous places in the Municipality to notify the public of the prices and sanctions imposed in this Ordinance.

SECTION 5. ENFORCEMENT. Members of the Palanan Police Force, Municipal Agriculturist Office, Barangay Officials, Barangay Tanods and Meat Inspector are hereby ordered to help in the implementation of this Ordinance by apprehending violators and issue citation tickets.

SECTION 6. FUNDING. An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance in the amount of *Fifty Thousand (Php 50,000.00) Pesos* shall be sourced from the MOOE of the *Offices of the Municipal Engineer and Municipal Agriculturist* and is hereby allocated every year thereafter.

SECTION 7. PENALTY CLAUSE. All violators will be penalized by a fine of One Thousand (Php 1,500.00) Pesos for the **1st Offense**; Two Thousand (Php 2,000.00) Pesos and confiscation of meat products for sale for the **2nd Offense**; and Two Thousand Five (Php 2,500.00) Pesos, confiscation of meat products for sale and cancellation of Mayor's Permit for the **3rd Offense**.

SECTION 8. A Citation Ticket shall be issued to the persons liable for any violation of this Ordinance upon finding of the violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Barangay Government where the violation was committed to be recorded in the barangay logbook. Payment of fine shall be made at the Barangay Treasurer or Office of the Municipal Treasurer, as the case maybe.

SECTION 9. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 10. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 11. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.
