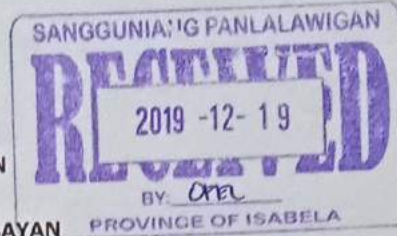

MUNICIPAL ORDINANCE NO. 2019 -23

**AN ORDINANCE REGULATING THE RATE OF MOTORBOAT FOR HIRE PLYING THE ROUTE FROM POBLACION TO COASTAL BARANGAYS AND VICE VERSA AND PRESCRIBING PENALTIES THEREFOR**

Be it ordained by the Sangguniang Bayan of Palanan, Isabela in session assembled, that:

**SECTION 1. RATE OF MOTORBOAT.** There is hereby approve rate of motorized *banca* for hire plying the route from Poblacion to coastal barangays and vice versa, to wit:

**SECTION 2. POSTING.** The rate of motorboat for hire provided under Section 1 should be prominently posted in conspicuous places in the terminal and inside the motorboat.

**SECTION 3. ENFORCEMENT.** The Members of the Palanan Police Force, Office of the Municipal Agriculturist, Barangay Officials and Barangay Tanods are hereby ordered to enforce the implementation and issue citation ticket to violators of this Ordinance. A Citation Ticket shall be issued to the persons liable for any violation of this Ordinance upon finding of violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Barangay Government where the violation was committed to be recorded in the Barangay logbook. Payment of fine shall be made to Barangay Treasurer or to the Office of the Municipal Treasurer, as the case maybe.

**SECTION 4. MAXIMUM CAPACITY OF PUBLIC UTILITY MOTORIZED BANCA.** The maximum capacity of the public utility motorized *banca* shall be seven (7) passengers and equipped with standard safety requirements, which the owner/operator has to comply with.

**SECTION 5. FUNDING.** An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance in the amount of Ten Thousand (P 10,000.00) Pesos shall be sourced out from the MOOE of the Office of the Municipal Agriculturist and is hereby allocated every year thereafter.

**SECTION 6. PENALTY CLAUSE.** Any person who violates the provisions of this Ordinance shall be punished by a fine of One Thousand (P 1,000.00) Pesos for the 1<sup>st</sup> Offense; One Thousand Five Hundred (P1,500.00) Pesos for the 2<sup>nd</sup> Offense; and Two Thousand Five Hundred (P2,500.00) Pesos and cancellation of Mayor's Permit for the 3<sup>rd</sup> Offense.

**SECTION 7. SEPARABILITY CLAUSE.** If any provision of this Ordinance found to be inconsistent with any law, other provisions or parts thereof not so affected shall remain in full force and effect.

**SECTION 8. REPEALING CLAUSE.** All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

**SECTION 9. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval.
