**MUNICIPAL ORDINANCE NO. 2019-30-A**

**AN ORDINANCE UNFUNDING THE APPROPRIATIONS FOR THE POSITIONS OF MIDWIFE V (SG - 17) AND MIDWIFE III (SG -13) UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER AND ADMINISTRATIVE AIDE IV (SG-15) UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER OF THE MUNICIPAL GOVERNMENT OF PALANAN, ISABELA.**

**WHEREAS**, the Municipal Mayor has requested this Body to enact an Ordinance unfunding certain positions contained in the Plantilla of Personnel for CY - 2019;

**WHEREAS**, there is a need to unfund certain positions in the Municipal Health Office and Municipal Budget Office of this Local Government Unit in lieu of the promotion and creation of new position items with the end view of bringing beneficial reforms in the Municipality;

**NOW THEREFORE**, Be it ordained by the Sangguniang Bayan in Session assembled, that:

**SECTION I.** There is a creation of positions in the different Offices of this Local Government Unit, which shall be allocated for the operation of Personal Services and other operating expenditures thereof;

**SECTION II. SEPARABILITY CLAUSE.** If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

**SECTION III. REPEALING CLAUSE.** All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

**SECTION IV. EFFECTIVITY.** This ordinance shall take effect immediately upon approval.




