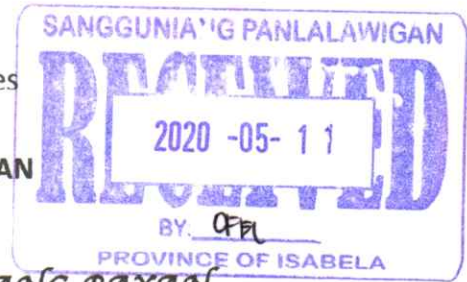

MUNICIPAL ORDINANCE NO. 2020-036

AN ORDINANCE ADOPTING MEASURES TO CONTROL THE SPREAD OF AFRICAN SWINE FEVER (ASF) WITHIN OUR AREA OF JURISDICTION

WHEREAS, DILG Secretary, Eduardo M. Ano issued an Advisory dated September 25, 2019, enjoining all Local Government Units to implement measures to control the spread of African Swine Fever (ASF) due to the rapidly increasing number of ASF case in the Philippines affecting pigs and wild boars and to contain the outbreak in our area of jurisdiction;

NOW THEREFORE, be it **ORDAINED** as it is hereby **ORDAINED** by the Sangguniang Bayan of Palanan in Session Assembled:

SECTION I. Short Title. - This Ordinance shall be known as the " **African Swine Fever (ASF) Control Ordinance**".

SECTION II. Compliance. The LGU shall take all feasible measures to prevent the spread and contain the outbreak of ASF. It shall take all necessary measures to ensure the effective implementation and enforcement of the provisions of this Ordinance. Towards this end, the LGU shall:

- 1) The LGU shall strictly monitor and ensure that no live hogs to enter with questionable origin such as but not limited to (1) Putting up a 24/7 animal quarantine checkpoints in various entry points (2) Ensuring that transport vehicles bearing hogs was checked if it has a veterinary health certificate and shipping permit;
- 2) Intensify monitoring of meat retailers and suppliers to ensure that pork products sold in the market have National Meat Inspection Service seals;
- 3) Monitor and inspect piggeries for affected live hogs and swine in this Municipality;
- 4) Raise public awareness on measures to help reduce cases of ASF outbreak by reporting presence of sick pigs to the proper departments or offices and remind the public to avoid dumping of carcasses in waterways and to coordinate in the proper way of disposing dead animals and in cleaning and disinfecting the environs of infected pig;

SECTION III. IMPLEMENTING MECHANISM. The Municipal Government of Palanan, Isabela through the Municipal Agriculture Office and Municipal Health Office shall adhere and actively implement the provisions of this Ordinance.

SECTION IV. IMPLEMENTING AGENCIES. The Municipal Agriculture Office (MAO), Members of the Palanan Police Force, Meat Inspector, Sanitary Inspector in coordination with the Barangays shall be the implementing bodies.

SECTION V. PENAL PROVISIONS. Anyone who are caught selling pork in the market with ASF disease shall upon conviction be punished by a fine of:

- 1st Offense** - One Thousand (Php 1,000.00) Pesos and confiscation for proper disposal;
- 2nd Offense** - One Thousand Five Hundred (Php 1,500.00) Pesos and confiscation for proper disposal;
- 3rd Offense** - Two Thousand Five Hundred (P2,500.00) Pesos, confiscation for proper disposal and cancellation of Business Permit.

SECTION VI. FUNDING. An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance shall be sourced out from the MOOE of the Municipal Agriculture Office and MDRRM Fund.

SECTION VII. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION VIII. REPEALING CLAUSE. All ordinances, rules and regulation or parts thereof whose provisions are in conflict with the provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION IX. EFFECTIVITY- This Ordinance shall take effect upon its approval.
