MUNICIPAL ORDINANCE NO. 2020-056

AN ORDINANCE IMPOSING A REGULATORY FEE ON FISHES AND OTHER AQUATIC PRODUCTS PER KILOGRAM FOR SALE AND TRANSPORT OUTSIDE THE MUNICIPALITY OF PALANAN, ISABELA

Be it **ORDAINED** by the Sangguniang Bayan of Palanan, Isabela, in session assembled that:

SECTION 1. REGULATED ACTS. No person shall sell and transport without securing the necessary permit and Auxiliary Invoice from the Office of the Municipal Agriculturist, thereby imposing a regulatory fee of **One Peso (P1.00) per kilogram** on fishes and other aquatic products collected, transferred and brought outside the Municipality.

SECTION 2. IMPLEMENTATION. The Municipal Agriculturist shall issue an Auxiliary Invoice before the sale and transport of fishes and other aquatic products pursuant to provisions of Municipal Ordinance No. 2019-09, series of 2019 - (An Ordinance Regulating the Transport of Fishes Outside the Municipality Thereby Depriving the Consumers of Palanan and Fixing Penalties for Violation Thereof) and Section 5 of Municipal Ordinance No. 2019-10, series of 2019 - (Disposing and/or selling of Fish and other Aquatic Products beyond the price ceiling and selling other than in the Public Market are strictly prohibited).

SECTION 3. IMPLEMENTERS. The Members of the Philippine National Police, the Office of the Municipal Agriculturist and Office of the Municipal Treasurer are hereby ordered to implement the provisions of this Ordinance.

SECTION 4. PENALTY CLAUSE. Any person who violates the provisions of this ordinance shall be punished by a fine of **One Thousand Five Hundred (P1,500.00) Pesos** for the **1st Offense**; **Two Thousand (P2, 000.00) Pesos** and confiscation of fish products for sale for the **2nd Offense**; and **Two Thousand Five Hundred (P2,500.00) Pesos**, confiscation of fish products for sale and cancellation of Mayor's Permit for the **3rd Offense**.

SECTION 5. PAYMENT. Fines shall be paid to the Office of the Municipal Treasurer based on the citation ticket issued by the PNP or Office of the Municipal Agriculturist and shall be recorded in the barangay logbook where the violation was committed.

SECTION 6. SEPARABILITY CLAUSE. If for any reason, any provision, portion or part of this Ordinance found to be inconsistent with any Law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 7. REPEALING CLAUSE. All provision(s) of Municipal Ordinances, Orders or Regulations inconsistent herewith is hereby amended/modified/repealed accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.
