MUNICIPAL ORDINANCE NO. 2020-057

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 05-04, SERIES OF 2005, INCREASING THE FARE RATE OF MOTORBOAT/LAUNCH PLYING THE ROUTE FROM PALANAN TO PROVINCE OF AURORA AND IMPOSING PENALTIES THEREOF

Be it ORDAINED by the Sangguniang Bayan of Palanan, Isabela in its session assembled that:

SECTION I. FARE RATE. The fare rate of motorboat/launch plying from Palanan-Dilasag route and vice versa is hereby increased as follows:

BRGY. CULASI, PALANAN- DILASAG	P 500.00
BRGY. SAN ISIDRO- DILASAG	P 450.00
BRGY. DIDADDUNGAN-DILASAG	P 400.00

SECTION II. IMPLEMENTATION.

- a) The fare increase of motorboat/ launch provided under Section I should be prominently posted in conspicuous places in the terminal and inside the vessel.
- b) The owner/operator shall submit the list of passengers or register in the logbook of the barangay duly noted by the Punong Barangay or its representative.
- c) The motorboat/launch shall be equipped with standard safety requirements, which the owner or operator has to comply with.

SECTION III. PENALTY. Any person who violate the provisions of this ordinance shall be punished by a fine of:

- 1st Offense** – One Thousand Five Hundred (P1,500.00) Pesos and stern warning; and
- 2nd Offense**- Two Thousand Five Hundred (P2,500.00) Pesos and cancelation of Mayor's Permit.

SECTION IV. ENFORCEMENT .The PNP Members, Office of the Municipal Agriculturist, Office of the Municipal Treasurer, Barangay Officials and Barangay Tanods are hereby ordered to implement the provisions of this Ordinance.

SECTION V.PAYMENT. Payment shall be made to the Office of the Municipal Treasurer or Barangay Treasurer. The members of the Philippine National Police or Office of the Municipal Agriculturist shall issue **Citation Ticket** to the violators and shall be recorded in the logbook of the barangay where the violation was committed.

SECTION VI. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION VII. REPEALING CLAUSE. All ordinances, rules and regulation or parts thereof whose provisions are in conflict with the provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION VIII. EFFECTIVITY- This Ordinance shall take effect upon its approval.
