MUNICIPAL ORDINANCE NO. 2020-061-A

AN ORDINANCE MANDATING THE TRANSFER OF EXISTING POSITIONS FROM THE OFFICE OF THE MAYOR TO THE NEWLY CREATED OFFICES IN THE MUNICIPAL GOVERNMENT OF PALANAN, PROVINCE OF ISABELA

WHEREAS, Section 76 of R.A. 7160, otherwise known as the “Local Government Code of 1991” provides that “ Every local government unit shall design and implement its own staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, all matters pertinent to human resources and development in local government units shall be governed by the civil service, pertinent laws and rules and regulations thereon, including such policies, guidelines and standards as the Civil Service Commission may establish;

WHEREAS, the Local Chief Executive requested the transfer of various positions from the Office of the Mayor to the three (3) newly created offices to complement its staffing pattern;

WHEREAS, this August Body is mandated to perform and implement its legislative action on the creation of significant offices of this Local Government Unit incidental for its efficient and effective governance;

NOW THEREFORE, be it Ordained by the Sangguniang Bayan of Palanan, Isabela in session assembled that:

SECTION 1. There is hereby transfer of existing positions from the Office of the Municipal Mayor to the Newly Created Offices of this Local Government Unit, to wit:

SECTION 3. SEPARABILITY CLAUSE. If any section or part of this ordinance is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION 4. REPEALING CLAUSE. All other ordinances, issuances, rules and regulations, which are inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY. This ordinance shall take effect upon approval and after fifteen (15) days posting and publication.


