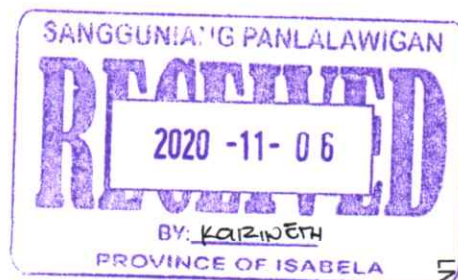

**MUNICIPAL ORDINANCE NO. 2020-062**

**AN ORDINANCE CREATING NEW POSITIONS FOR CASUAL APPOINTMENTS UNDER THE DIFFERENT OFFICES OF THE MUNICIPAL GOVERNMENT OF PALANAN, ISABELA FOR THE PERIOD COVERING SEPTEMBER 2020 TO DECEMBER 2020 AND APPROPRIATING FUNDS THEREFOR**

Be it **ORDAINED** by the Sangguniang Bayan in Session assembled, that:

**SECTION 1.** There are hereby created New Plantilla Positions for **Casual Appointments** under the different offices of this Local Government Unit, which shall be sourced-out from the existing budget of the vacated temporary positions under the Personal Services, to wit:

**SECTION 3. SEPARABILITY CLAUSE.** If any section or part of this ordinance is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

**SECTION 4. REPEALING CLAUSE.** All other ordinances, orders, issuances, rules and regulations, which are inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 5.** This ordinance shall take effect on September 1, 2020.
