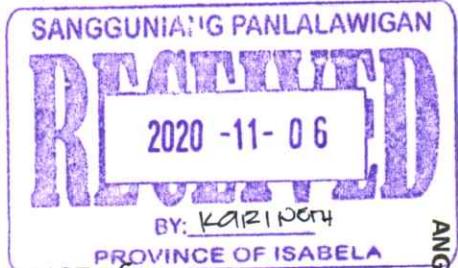

MUNICIPAL ORDINANCE NO. 2020 - 063

AN ORDINANCE CREATING THE POSITION OF ZONING OFFICER I (SG 11) UNDER THE OFFICE OF MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR OF THE MUNICIPAL GOVERNMENT OF PALANAN, ISABELA AND APPROPRIATING FUNDS THEREFOR

WHEREAS, the Municipal Mayor has requested this Body to enact for the creation and appropriation of the said position contained in the Plantilla of Personnel;

WHEREAS, there is a need to create the above-stated position in the Office of the Municipal Planning and Development Coordinator of this Local Government Unit with the end view of bringing beneficial reforms in the Municipality;

NOW THEREFORE, Be it Ordained by the Sangguniang Bayan in Session assembled, that:

SECTION I. There is hereby creation and appropriation of Zoning Officer I in the Office of MPDC of this Local Government Unit, which shall be allocated for the operation of Personal Services and other operating expenditures thereof;

SECTION II. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION III. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION IV. EFFECTIVITY. This ordinance shall take effect immediately upon approval.
