MUNICIPAL ORDINANCE NO. 2020 -065

AN ORDINANCE CREATING THE FOLLOWING PLANTILLA POSITIONS UNDER THE DIFFERENT DEPARTMENTS/OFFICES OF THE LOCAL GOVERNMENT UNIT OF PALANAN, ISABELA AND APPROPRIATING FUNDS THEREOF

Be it **ORDAINED** by the Sangguniang Bayan in Session assembled, that:

SECTION 01 - The following *Plantilla Positions* under the different offices of this Local Government Unit are hereby created and appropriating the necessary funds thereof, to wit:
