MUNICIPAL ORDINANCE NO. 2020 -068-A

AN ORDINANCE RETITLING THE POSITION OF ACCOUNTING MACHINE OPERATOR (SG-7) TO COMMUNITY DEVELOPMENT ASSISTANT I (SG-7) UNDER THE CASUAL PLANTILLA OF THIS LOCAL GOVERNMENT UNIT

WHEREAS, the Local Chief Executive requested for the change of position title from Accounting Machine Operator (SG-7) to Community Development Assistant I (SG-7) because the former position is only applicable to national agencies;

WHEREAS, there is a need to retitle the said positions with the same Salary Grade in accordance with the Revised Index of Occupational Services (IOS), Position Titles and Salary Grades in the *Local Government Units*;

NOW THEREFORE, Be it **ORDAINED** by the Sangguniang Bayan of Palanan, Isabela in session assembled, that:

SECTION 01. There is hereby change of position title from **Accounting Machine Operator (SG-7) to Community Development Assistant I (SG-7)** in the *Plantilla of Casual Positions* of this Local Government Unit;

SECTION 02. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 03. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 04. EFFECTIVITY. This ordinance shall take effect immediately upon approval.
