MUNICIPAL ORDINANCE NO. 2020 -068

AN ORDINANCE RETITLING THE FOLLOWING CASUAL POSITIONS WITH THE SAME SALARY GRADE UNDER THE DIFFERENT OFFICES OF THIS LOCAL GOVERNMENT UNIT

WHEREAS, the Local Chief Executive requested the following *Plantilla Positions* for the change of position titles under the different offices of this Local Government Unit;

WHEREAS, there is a need to retitle the said positions with the same Salary Grade in accordance with the Revised Index of Occupational Services (IOS), Position Titles and Salary Grades in the Local Government Unit;

WHEREAS, this August Body firmly believes that it will bring beneficial reform in the Municipality;

NOW THEREFORE, Be it **ORDAINED** by the Sangguniang Bayan of Palanan, Isabela in session assembled, that:

SECTION 01. The following casual positions under the different offices/departments of this Local Government Unit are hereby retitled, to wit:

BUDGET AND MANAGEMENT ANALYST - (SG 11)	LOCAL REVENUE COLLECTION OFFICER - (SG 11)
AGRICULTURAL PRODUCTS INSPECTOR I - (SG 6)	LIVESTOCK INSPECTOR I - (SG 6)
SENIOR ADMINISTRATIVE ASSISTANT II - (SG 15)	MANPOWER DEVELOPMENT OFFICER II - (SG 15)

SECTION 02. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 03. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 04. EFFECTIVITY. This ordinance shall take effect immediately upon approval.
