MUNICIPAL ORDINANCE NO. 2020-071-A

A ORDINANCE MANDATING THE TRANSFER OF ADMINISTRATIVE AIDE VI (SG-6) FROM THE OFFICE OF THE MUNICIPAL VICE MAYOR TO THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG BAYAN OF THE MUNICIPAL GOVERNMENT OF PALANAN, PROVINCE OF ISABELA

WHEREAS, Section 76 of R.A. 7160, otherwise known as the “Local Government Code of 1991” provides that “ Every local government unit shall design and implement its own staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, all matters pertinent to human resources and development in local government units shall be governed by the civil service, pertinent laws and rules and regulations thereon, including such policies, guidelines and standards as the Civil Service Commission may establish;

WHEREAS, the transfer of existing position is imperative to complement its staffing pattern to the newly created office;

NOW THEREFORE, Be it Ordained by the Sangguniang Bayan of Palanan, Isabela in session assembled that:

SECTION 1. The position of Administrative Aide VI (SG-6) under the Office of the Municipal Vice Mayor shall be transferred to the Office of the Secretary to the Sangguniang Bayan of this Local Government Unit.

SECTION 2. The powers and functions of the said positions shall be in accordance with the guidelines and standards set forth by the Civil Service Commission.

SECTION 3. SEPARABILITY CLAUSE. If any section or part of this ordinance is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION 4. REPEALING CLAUSE. All other ordinances, issuances, rules and regulations, which are inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY. This ordinance shall take effect upon approval and after fifteen (15) days posting and publication.
